Introduction:

With COVID-19 Pandemic, other public health programs and services were affected where COVID-19 response operation was prioritized. This year 2022, we have started to resume implementation with strict compliance of Minimum Public Health Standards (wearing of face mask and face shields, physical distancing, hand sanitation and washing, surface and frequent facility disinfection) as part of new normal to prevent local transmission. To attain herd immunity by increasing COVID-19 Vaccination coverage of the eligible population will increase community protection and control COVID 19 infection.

In every transaction and access of services, all clients and patients will first be assessed and classified at the TRIAGE area, as to what case and where department/ services they will go, with controlled numbers to avoid overcrowding and assure proper distancing in every department.

1. Animal Bite Treatment Center

Rabies control program aims to provide pre- and post - exposure prophylaxis to persons at risk (animal handler and animal bite patients) to prevent Rabies Virus mortality. Tanza Animal Bite Treatment center is Philhealth accredited and provides free vaccination for PhilH members and beneficiaries under No Balance Billing (NBB) but will be charged 650/ vaccination and 1,700/25 kg Body Weight for erig injection.
